#### **Guarding Against Romance Scams**

A romance scam takes place when a fraudster displays romantic intentions towards you using social media platforms or dating websites. The fraudster works to gain your affection and trust and then uses that trust to get you to send them money under false pretenses when their true intent is to defraud you or cause you to become complicit in illegal activities. If someone you meet online needs your bank account information to deposit money, they are most likely using your account to carry out other theft and fraud schemes.

**1.** <u>Never</u> give out your home banking login credentials to anyone for any reason .

**2.** <u>Never</u> send money to someone you have only met online and have never met in person.

**3.** <u>Never</u> allow someone to deposit a check to your account using mobile deposit.

**4.** <u>Never</u> send money to anyone claiming to be overseas that needs financial assistance to return to the United States if you have never met them in person.

**5.** Look for typos, grammatical errors such as misuse of punctuation and capitalization and spelling, mismatched names or invalid financial institution information on any checks received

**6.** If the individual asking you to perform any kind of financial transaction communicates only through social media platforms or dating websites and is not willing to speak on the phone or meet in person, do not agree to their request


**7.** <u>Never</u> perform financial transactions for someone you have only met online. These transactions could include, but are not limited to, accepting funds from someone with the stipulation you send a portion of the funds to someone else via money order, iTunes gift cards, Bitcoin, money wire, Cash App, Venmo or other money transfer apps.

8. Do not deposit a check using mobile deposit if it was mailed to you unexpectedly, a request to return a portion of the funds was made, or the check has a stamped endorsement on the back.

**9.** Keeping any form of overpayment, or sending a portion of the funds using any of the methods listed above, may result in you being held responsible for repayment of all funds spent if the transaction is deemed fraudulent.
